Lecture Synopsis

Prof Merkin has kindly agreed to give a lecture update on recent developments in insurance law.

The update is likely to discuss, inter alia, recent developments on the following topics:

- UK reform update: third parties legislation; damages for late payment; insurable interest bill
- Fair presentation: reinsurance; marine insurance
- Professional indemnity: aggregation; operation of claims made policies
- Fraudulent claims
- Subrogation
- Duties of producing and placing brokers

Speaker Background

Prof Merkin QC is Lloyd's Professor of Commercial Law at the University of Exeter. He is also Special Counsel to DLA Piper. Prof Merkin is a prolific author on insurance law as well as on arbitration law.

In 2015 he was made a QC honoris causa by the Crown.

Prof Merkin QC is a strong supporter HILA and was key to HILA's revival in 2011.
